## REQUIREMENTS FOR LOST OR DESTROYED VESSEL CERTIFICATE

---

In the event of a lost or destroyed Certificate the following requirements are incorporated in the application for a new Certificate to be issued.

1. The full names, address and occupation of the owners of the vessel.
2. Where applicant is a representative of the registered owner, the capacity in which they are applying is to be stated e.g. personal representatives of the deceased or officials of a company. If they are representing a Company they are to state expressly that they are authorized to make the declaration on behalf of the owner.
3. Description of the vessel in accordance with the Certificate.
4. State when, where and how the loss occurred, where the Certificate was kept, by whom and when and where it was last seen.
5. Indicate who had access to the Certificate if another party was holding it.
6. State what searches and enquires were made, by whom and with what result
7. State whether another party was holding the Certificate.
8. Undertaking to deliver up Certificate to Registrar General for cancellation if it is found
