APPLICATION FOR REGISTRATION OF TRANSFER OR TRANSMISSION OF SHARES IN A JAMAICAN SHIP

Application for Registration of Transfer of a Ship

In the case of a transfer of a ship, the following documents will be required:

- Completed Application for Registration upon Transfer or Transmission of Shares in a Jamaican Ship (Form JSR013)
- 2. A duly executed Bill of Sale
- 3. Completed Declaration of Transfer (JSR063)
- 4. Jamaican Passport or; Partnership Deed or; Certificate of Incorporation, Notice of Directors, Certificate of Good Standing (as the case may be).
- 5. Consent from the mortgagees where applicable for the change in ownership to be entered.

Application for Registration upon Transmission of a Ship (upon death, bankruptcy, etc.)

In the case of a transmission of a ship, the following documents will be required:

- Completed application for Registration upon Transfer or Transmission of Shares in a Jamaican Ship (Form JSR013)
- 2. A completed Declaration of Transmission (JSR83)
- 3. Bill of Sale along with
 - a. Proof of title as provided by the courts (in the case of bankruptcy)
 - b. Court Order vesting the right to transfer the vessel (evidencing sale ordered by the Court); or
 - c. Death Certificate
- 4. Grant of Probate or Intestacy
- 5. Consent from the Mortgagees where applicable, for the change in ownership to be entered.
